PARKING RULES FOR LAKEVIEW CONDOMINIUMS RESOLUTION

1. All Units can register two vehicles to be parked in a reserve spot.

2. Every resident's vehicles need to be registered in order to park in a reserved spot. A registry form with the required information and supporting documents to prove the vehicle belongs to an owner or tenant that resided in our complex must be filled out and file with our management company.

3. Vehicles not on our registry may park in a visitor marked spot, unmarked spot or the on the street.

4. All vehicles must be on our registry list to park in any reserved spot. If it is not on our registry list it will be towed immediately with no warning at the vehicle owner's expense and a violation fine could also be issued to the owner of the unit for repeat offenders.

Who will be towed?

1. Any vehicle parked in a reserved spot not listed on the registry. Registry list can be review on our web page www.lvcondos.org under the PARKING link.

2. Any vehicle parked in a no parking, fire lane, tow zone or interfering with the flow of traffic.

3. Any inoperative vehicle with flat tires or in disrepair or expired tags.

4. Any vehicle violating our declarations; please read our CCR's on our web page www.lvcondos.org Under the CCR's link.

5. Vehicles will also be towed if they are parked unattended in a loading area for more than ten (10) minutes at the vehicle owner's expense.

6. Vehicles parked in front of the garages if unattended.

7. Vehicles with company logos that are not performing work on related maintenance or repair of our complex hired by the association.
